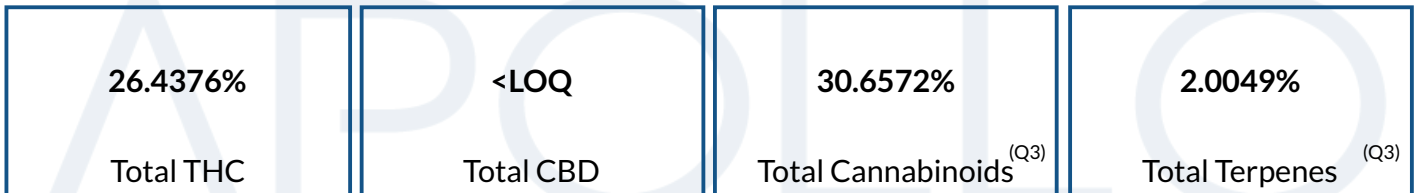

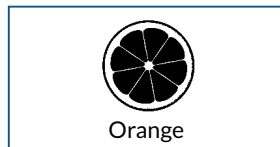
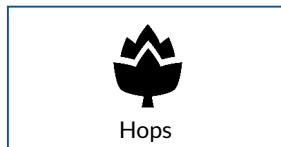

Qualifier Notation	Qualifier Description
